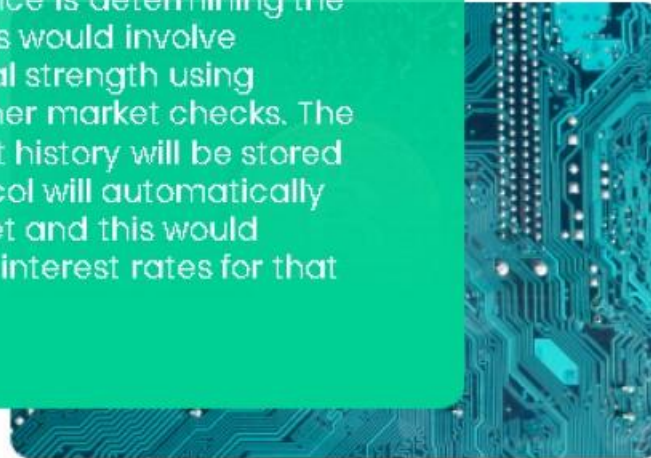


### Asset Evaluation :

One of the key issues in trade finance is determining the quality of the asset underlying. This would involve understanding the buyer's financial strength using financial data points as well as other market checks. The financial data points and payment history will be stored on the on-chain ledger. The protocol will automatically determine the rating for each asset and this would influence the collateralization and interest rates for that asset.

### Porting Existing Infrastructure to L2 Blockchain Networks:

The first element of this platform is the migration of the current trade finance ecosystem to an L2-based blockchain network. The importance of L2 is important because the business transactions require both high speed and low transaction costs. There are currently several L2 networks that are Ethereum compatible and are highly configurable. This means that you can migrate your CeFi system from DeFi to L2 and still be connected to the mainstream Ethereum network.



## Borrower Evaluation :

Just like asset evaluation, the standards for borrower evaluation will be defined by the protocol. In normal trade transactions, the risk to the borrower is low, but their chain activity, profile building and submission of financial documents will result in algorithmic borrower ratings. The rating will also affect the interest rate at which they can borrow.

## Smart Products:

With both the borrower and asset valuation in place, the borrower can reduce the cost of borrowing through a variety of methods, such as providing additional collateral such as BTC, ETH, or Stable Coins, borrowing in Trades Coins, offering validation services, etc.

## Exposure Risk:

One of the most important aspects of risk management within trade finance is not overexposing the protocol to one asset or one entity. Again, this would be done algorithmically. For example, when a certain percentage of lending is impacted against a particular entity or asset, a hard stop would be applied until the current margins are wiped out. Similarly, borrower side rules would be built that the protocol would not be exposed to a single borrower risk.

## TRADE Token Coin Utility



### TRADE token will be used for the following key functions :

- ☑ TRADE token will allow users to participate in the governance of the protocol. The governance rights are based on staking, meaning that those who stake more TRADE will have more control over various governance decisions, such as running the protocol.
- ☑ TRADE will also incentivize users to earn rewards on a regular basis, which will help the community to continue to grow and develop the protocol.
- ☑ TRADE token will also provide liquidity providers with the opportunity to stake their own TRADE tokens for securing the network.
- ☑ Finally, TRADE tokens will serve as a settlement tool in the various bridges that will allow the liquidity to be shared with other sidechains or mainnets.



## Legal Aspects

In some countries, including the US, China, and other countries, ICOs and cryptocurrencies are illegal. People from these countries are not allowed to participate in ICOs.



TRADE Coins will help build trust between stakeholders and give investors peace of mind that they are dealing with trustworthy buyers and sellers.



Once these coins gain traction and users, they can grow as a standalone cryptocurrency with their own market.
